Shrl Dharmasthala Manjunatheshwara College of Engineering & Technology, Dhavalagiri, Kalaghatagi Road, Dharwad -580 002, Karnataka should submit the Compliance Report at least six months before the expiry of validity of accreditation mentioned above to be eligible for consideration by the concerned Committee in NBA for further processing of the accreditation status.
