Preamble:

On Commemoration of Silver Jubilee year of the University, the University has decided to provide extra attempts to the students registered under the umbrella of the VTU from the year 1998-99. The details are slated as below:

Accordingly, **as one time measure** the following is **notified** in accordance with the aforementioned subject and references.

1 **Applicability** : The contents of this notification are applicable to the students admitted from the year 1998-99 upto below mentioned batches at VTU's Constituent, Affiliated and Autonomous Colleges

3 **Number of Additional Attempts:**

Two additional attempts are provided to Under Graduate and Post Graduate students to complete their Degree.

4 Eligibility to avail the benefit :

UG Students : Must have completed the course in full i.e. 8th / 10th semester (as applicable) and appeared for all semesters examination at least once and having backlog subjects to complete the degree in full.

5 PG Students :

- a) MBA Must have completed all four semester course work and attended 4th semester examinations at least once.
- b) MCA Must have completed all six semester course work and attended theory examinations of all semester at least once.
- c) M.Tech. Must have completed all three / four semester course work and attended theory examinations upto 3rd / 4th semester at least once.

6 Pre- Registration

- a The students (both UG and PG) who intend to utilize this benefit, have to register themselves separately on VTU web portal. The student who is registering has to pay the registration fees of Rs. 500/- (non refundable) through payment link in the online application.
- b The students from autonomous colleges (non-autonomous and autonomous scheme) are also required to register their name for these examinations. The non-autonomous scheme students from autonomous colleges have to attend VTU examinations only. Autonomous College has to take due care in this regard.
- c The pre-registration data in respect of autonomous scheme students of autonomous colleges will be shared with the respective colleges after registration.
- d The details in respect of pre-registration will be notified by the Registrar (Evaluation).

7 Norms for Submission of Dissertation report for PG students :

- a The students must have completed the course requirements like attendance, IA, and appeared for examinations in all the subjects of all the semesters, as specified in the respective scheme and undergone necessary course requirements like successful completion of all subjects, industrial training, corporate exposure learning, internship, etc., to gain the eligibility to submit the dissertation.
- b Students not completed the course requirements as slated in 7(a) are permitted to submit the dissertation reports, after successful completion of course requirements. In such a case, the dissertation report shall be submitted within six months from the date of results, with a **new topic relevant to the current scenario under the guide allotted by the college.**

- c Students completed course requirements as slated 7 (a) and submitted the dissertation and waiting for viva-voce are also required to submit the dissertation report with a **new topic relevant to the current scenario under the guide allotted by the college, within six months from the date of notification.**
- d Students completed course requirement as slated 7 (a) and not submitted the dissertation are required to submit the dissertation report with a **new topic relevant to the current scenario under the guide allotted by the college, within six months from the date of notification.**
- e The submission of dissertation report will be online and the reports will be verified for plagiarism check.

7 **Examination and Re-evaluation Fees (all fees are non refundable):**

A Rs.5000/-per subject to the maximum of Rs.75,000/-

Note : Dissertation report is considered as a subject.

b The revaluation fee :

a) UG students will be Rs. 3000/-per subject

b) PG students will be Rs. 5000/-per subject.

8 **Conduct of Examination :**

The details regarding the Examinations to be conducted in this regard will be notified by Registrar(Eval.), VTU, separately. Queries, if any, may be submitted to Registrar(Eval.) through the Principal of respective college.

The terms of this notification shall apply to all students enrolled in Affiliated, Constituent and Autonomous Colleges within this university.

The contents of this notification shall be brought to the notice of all the concerned.
